Guidelines for Local Business Enterprise (LBE) Applicants

Prior to submission of a LBE Certification Affidavit of Eligibility (Affidavit), it is expected that the applicant firm's address, legal name, and Los Angeles Business Assistance Virtual Network (LABAVN) Company ID Number reported on the Affidavit match with the information reported on its BAVN Company Information page.

During the review process, supporting documents will be requested to prove that the applicant firm meets the program's LBE eligibility criteria. Examples of these documents are:

A copy of the office/work space's Rental or Lease Agreement, and other documents needed by the certification analyst doing the review.

If applicants select **Criteria 3A or 3B** they will need to submit copies of the Quarterly Wage Reports or Form DE9Cs, Payroll Records, and a list of full time employees working within Los Angeles County (Social Security numbers must be redacted).

Requests will be sent via e-mail to the firm's listed BAVN account administrator. Therefore, it is very important to ensure that the account administrator's email address is up to date. We are not responsible for misdirected e-mail.

Do not upload supporting documents onto your BAVN account and do not send hard copies to our office.

Please note that the following may not qualify as a work space:

- A virtual office and/or an executive suite
- An arrangement for the right to use an office space on an "as needed" basis
- A P.O. Box or mail center where no work space in the County of Los Angeles is exclusively reserved for the firm at all times
- Work space provided in exchange for services as opposed to monetary rent
- Home office, if the owner(s) or officer(s) of the business maintains an office outside of his/her residence
- Property that does not contain a physical office
- "Hotel Style", membership, licensor/licensee agreements for space

Please be advised that uploading the Local Business Certification Affidavit of Eligibility does not automatically qualify you for the LBE certification. The BAVN account of a certified LBE shows "Verified" under its "Status" column once the certification is approved.
